

Subject – Report on crimes of **vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Any Kuki Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, my family left our rented house owned by Thongkhomang (mobile no.9682481794) while I was away on duty in Jammu, serving under the Indian Army (10th Assam Regiment) located at 1st Street, New Lambulane, P.O. & P.S.- Porompat and District- Imphal East. And, it came to our knowledge that our deserted resident was looted and vandalized by a group of Meetei/Meitei miscreants suspected to be members of Arambai Tenggol and Meitei Leepun on the 4th of May, 2023 at around 7:15 PM along with my Two-Wheeler, newly purchased Honda Activa 6G, metallic white in colour, with no registration no. yet, which was looted by the said miscreants.

The criminals broke open the door, destroyed and looted every valuable property from my resident along with the above-mentioned Two-Wheeler, worth about Rs.13,39,700/- (*Rupees Thirteen Lakhs Thirty-Nine Thousand Seven Hundred*) only in total.

That, it may be reported here that the miscreants were shouting slogans like- “KANGLEIPAK YAIPHARE”; “KUKI HATLO”; “HAO HATLO”; etc. while they were carrying out their criminal activities.

That, I am filing this information lately because there is a great danger to my family and due to which I was at different places and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
