I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident
of New Lambulone, Imphal.

That, on the 3rd May, 2023 at 5 pm my above said residence "Owned/Rented"
was attacked, destroyed, looted and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from
my residence and premises worth Rupees 70,50,000/- (Approx.) and they burnt down
all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were
shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering
an **FIR/Zero FIR** under relevant sections of Law.
