

Sir,

I have the honour to state that I belongs to a Kuki Tribe, a scheduled tribe recognized under the constitution of India.

That, due to the communal violence that broke out from 3<sup>rd</sup> May, 2023, my family was forced to abandon our home (i.e. House No. 10 of Haokip Veng) located at Mahabali Road, Haokip Veng, Imphal East District, Manipur, PS - Porompat. In that, among others, my two-wheeler vehicle Royal Enfield (Black in colour) bearing registration no. DL 12SG1832, Chassis No. ME3U3S5C1GD573027, Engine No. U3S5C1GD165609, registered in my name, was kept at the locked garage inside the campus of the above mentioned house.

However, I came to learn from neighbourhood that the said vehicle, which is worth Rs. 1,93,000/- approximately was stolen away by unknown miscreants on 04-05-2023 at around 7 p.m.

It is therefore requested to kindly take up necessary legal action against the said unknown miscreants, and help recover the stolen vehicle.

As I had escaped to outside, I could not report on time.
