



Subject - Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Vaiphei Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I left my rented house owned by *Akip* located at *Dimdailong, Checkon, P.O. & P.S. - Porompat*, District- Imphal East, it has come to our knowledge that our deserted house was attacked and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tenggol and Meitei Leepun on the 6th of May, 2023 at around 1:00 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs. 8,50,700/- (Rupees Eight Lakhs Fifty Thousand Seven Hundred) only.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

That, I am filing this report lately as I was in different remote areas, therefore, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
