Subject: FIR on my properties looted from DE East, Manipur on the 16/10/2023

Sir.

With due respect, I would like to state that I am John Banyan Songate, occupant of DDK Staff Quarter No.C/26, Porompat, Imphal East, Manipur which was looted on the 16th of October, 2023 at around 5:30 pm.

That Sir, as a result of the law-and-order situation which suddenly erupted on the 3rd May 2023, my family along with several families belonging to Kuki-Zo community were evacuated from our quarters and transported to a safer place at IGAR, Mantripukhri, Imphal by the Indian Army on the 7<sup>th</sup> of May 2023 leaving behind all our household items and properties in our respective quarters. As per the instruction of the Head of Office, before leaving, we locked our quarters and handed over the key to our Office Staff Quarter Caretaker Shri RK Amarjeet Singh, PEX, so as to protect and safeguard our belongings which we left behind from any outside miscreants.

Shri RK Amarjit Singh, PEX (Staff Quarter Caretaker), on the 15<sup>th</sup> October 2023 through phone call had informed one of the Internally Displaced Staff that we must vacate our belongings from the quarter before 16<sup>th</sup> October 2023. Following this, I requested a fellow staff residing in the same quarter to help vacate our belongings to a safer place. Ironically, Shri RK Amarjeet Singh, PEX (Staff Quarter Caretaker) disagreed and opposed the vacating of our belongings again.

Unfortunately, on the 16th of October 2023, I received information from a reliable source that the lock on my Quarter No. C/26 was opened and miscreants from outside were given free access which resulted in the looting of all our belongings and properties leaving our quarter empty at around 5:30 in the evening. This proves the malicious act of looting is carried out under the knowledge and permission of none other than Shri RK Amarjeet Singh, PEX (Staff Quarter Caretaker).
