

Lungthanglien Haokip of Chassad Village, Kamjong District, Manipur would like to draw your kind attention to lodge my complain against the lost of my properties on the 4<sup>th</sup>, 5<sup>th</sup> and 22<sup>nd</sup> May, 2023 at Chassad Avenue. On the said dates and days an unidentified Manipuri mob entered to my rented rooms a resident of Mr. Ngamson Touthang at Chassad Avenue, New Checkon, Imphal East and looted, vandalized, destroyed all my belongings and properties. All the vandalized remains were again burnt on 22<sup>nd</sup> May, 2023. Due to current situation between two communities.

I place this report lately as I was asked by my landlord to report all my losses separately. All the destroyed properties are estimated to around 10 Lakhs, details of it is enclosed along.

I request your esteemed office to take appropriate action.
