

Sir,

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **SL Haopu** aged about 59 years S/o **Nekcha Vaiphei** Belonging to the **Vaiphei Tribe** / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I a permanent resident of **New Lambulane 1st Street Near Tribal Market , Imphal-East District Manipur. P.O., &P.S., Porompat.**
2. That at about 8 am on the **4th May 2023**, due to the ethnic violence in the state I and my family have to run for our lives leaving behind our house along with all our belongings and took shelter at **Mantripukhri Assam Rifles Camp**, and in the process some unknown miscreants suspected to be a members of **Arambai Tengol and Meitei Leepun** have looted our house including all our belongings .
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.85,00,000 (Rupees Eighty Five Lakhs) only**
4. Fortunately, I managed to escaped from the Violence, and now currently taking refuge at **Salem Veng Churachandpur .**
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned Address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
