

With reference to the above cited subject I have the honour to report to you as follows :


1. That I **B Golianmang** aged about 60 years H/o **Pamzaniang** Belonging to the **Paite Tribe / Community**, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **New Chachon Nongpok Ingkhoh Imphal-East District Manipur. P.O., & P.S., Porompat.**
2. That at about 9 am on the 4th May 2023, due to the ethnic violence in the state, my family have to run for their lives leaving behind our house along with all our household items and belongings and took shelter at **Lamphel CRPF Camp**. And in the process some unknown miscreants have looted our house, including all our Household items, belongings and also our electronic items as well as our construction items and machineries.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs.2,50,00,000/- (Rupees Two Crore Fifty Lakhs)** only
4. Fortunately, my family managed to escaped from the Violence, and now currently taking refuge at **New Lamka Gouchinkhup Veng Churachandpur.**
5. That, I am filing this information lately because I was at my posting place (**Tengnoupal**) due to which I was at different place And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.


