With reference to the above cited subject I have the honour to report to you as follows

- That I Jonathan Lhungdim aged about 37 years S/o Thangpu Lhungdim Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989 and that I a resident of New Lambulane 3rd Street, Imphal-East District Manipur. P.O., &P.S., Porompat.
- That at about 1:30 pm on the 6th May 2023, due to the ethnic violence in the state I and my family have to run for our lives leaving behind our rented house owned by Mrs. Phalneilhing Singson at the above mentioned address, along with all our belongings, and took shelter at Mantripukhri Assam Rifles Camp, and in the process some unknown miscreants suspected to be a members of Arambai Tengol and Meitei Leepun have looted and then burnt down our house rented house including all our belongings
- That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.3,50,000 (Rupees Three Lakhs Fifty Thousand) only
- Fortunately, I managed to escaped from the Violence, and now currently taking refuge at Molnom Village, Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at The above mentioned Address. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
