



Subject - Report on Looting of household items assets and discrimination of Schedule Tribes

Sir,

With reference to the above cited subject I have the honour to report to you as follows :-

1. That I **Hatnu Singoit** aged about 65 years W/o **Seiboi Singoit** Belonging to the **Thadou Tribe / Community**, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SCST (Prevention of Atrocities) Act, 1989**, and that I am a permanent Resident of **Mission Lane, Sanjenghong Imphal-East District Manipur, P.O. & P.S. Parompat**.
2. That at about 10 am on the 6<sup>th</sup> May 2023, due to the ethnic violence in the state, my family and I have to run for our lives leaving behind our house along with all our household items and belongings. And in the process some unknown miscreants suspected to be members of **Arambai Lengol** have looted our house, including all our Household items and belongings.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 95,00,000/- (Rupees Ninety Five Lakhs) only**.
4. Fortunately, my family and I managed to escaped from the Violence, and now currently taking refuge at **Tuibong Khopiveng Churachandpur**.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned place. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
