Subject – Report on crimes of **vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Gangte Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Washim & family (7628892086 / 8575634442) located at New Lambulane, 1st Street near Mengshi Inn, P.O. & P.S.- Porompat, District- Imphal East on the **4th of May, 2023** at around **5.30 PM**, and it has come to our knowledge that our deserted house was attacked, vandalised and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meitei Leepun on the **15th of June, 2023** at around **1:30 PM**.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about **Rs. 4,36,000/- (Rupees Four Lakhs Thirty-Six Thousand)** only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
