That, I am a Scheduled Tribe belonging to the Gangte Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house owned by Washim&family (7628892086 / 8575634442) located at New Lambulane, 1st Street near Mengshi Inn, P.O. & P.S.- Porompat, District-Imphal East on the 4th of May, 2023 at around 5.30 PM, and it has come to our knowledge that our deserted house was attacked, vandalised and looted by a Group of radical Meeitei/Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 15th of June, 2023 at around 1:30 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs. 4,36,000/- (Rupees Four Lakhs Thirty-Six Thousand) only.

That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
