

In response to SP/Ukhrul order no. C-1 (G/P)/2023-SP(UKL)/9940 dated 14/12/2023, a combined team of Ukhrul Police, 6th Bn. Manipur Rifles, Personnel of NAB, District Forest Department and Volunteers of CSOs led by Insptl. Chuingam Ningshen (OC/UKL-PS) under the supervision of Superintendent of Police, Ukhrul, conducted illegal poppy destruction at Sihai Khunou & Khamasom Walely hill range on 15/12/2023 from 11:00 a.m to 3:00 p.m by the order of the Magistrate on duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 48 ND & PS Act, 1985 (as amended). An area of about 15 (Fifteen) acres approximately was destroyed. It is expected to yield about 150 (One hundred fifty) Kg, 10 Kg per acre of opium (Approx). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court and for further legal action. Hence, a Suo- Moto case under **FIR No. 27(12)2023/UKL-PS, U/s 18 (b) ND & PS Act** was registered and endorsed to SI. PS Rockson for investigation.
