with due respect and humble submission, I implore the following few lines for kind consideration and favourable action please.

I, Ngairanbam Parihanba Singh (38)yrs S/o late Ibochou Singh and Ng. Pemcha Devi of Kontha Khabam Mayai Leikai PS-Heingang and employee of Central Government (Inspector in CRPF) posting at 86<sup>th</sup> Bn. CRPF Wedded with Bidyapati Devi (45)yrs daughter of Laishram Iboton Singh and L. Indrani Devi of Singjamei Waikhom Leikai. She is working in Manipur Development Agency, Imphal, Govt. of Manipur

In the name of 2(two) weeks official training at Khanapara, Guwahati she left Imphal on 20<sup>th</sup> Aug. 2019 and returned back on 5<sup>th</sup> Sept 2019. She told me that she was accompanied 3(three) ladies and 3(three) gents altogether 7 (seven) in the training. During her visit to Guwahati for training, I was posted at 210 COBRA. Bn. Guwahati waiting for 3(three) months Opertional tenure ar Chartisgarh on 30<sup>th</sup> Aug. 2019. After returning back from 3 (three) months operational tenure at Chhartsigarh, I approached her office on 26<sup>th</sup> Dec. 2019 and enquired regarding the office training. The Offical staffs/Staff (training section) who were present on that day opined that there is no training during the months of Aug- Sep,2019 at Khanapara Guwahati and there is no record found in the registered that my Spouse went for training of the above mentioned duration. After Knowing the fact and circumstance, I told her that why you have cheated on me and big lie to your husband. From on that day onward, She never back came to home and found that she is staying at her maternal home without my consent or without informing to me. On cheating case on me, being a husband I filed a divorce case in the court of Family Court, Lamphelpat, Manipur, Imphal bearing Matrimonial Divorce suit No. 09/2020. The next Court hearing falls on 06-12-2023.

on 28<sup>th</sup> Nov 2023 approx. 0740hrs when I was in Imphal (home), received a phone call from unknown number (9233520940) identified himself that they belong to Imphal valley based UG group and told me that on behalf of my wife (Laishram Bidyapati Devi) complaint, they threaten me to come to their camp/ custody which is located at Moirang under Bishnupur District to finalise/ settle the said divorce case which is still pending at Family Court, Imphal West. But I did not attend there. On that day onward they frequently calling in my mobile phone and threaten again and again to come to the place where they decided otherwise they will not spare my life. I knew that I was not safe to stay in Imphal, came to my posting place i.e. Nungtek, Noney district, Manipur. The unknown miscreant threaten to the family members, relatives etc. and also threaten them to bring me in their custody/ camp. If failing to produce me or self attend, they warned or threaten that they will not spare my life.

Therefore, I came to known that under the Supervision/direction of my wife, she has contacted that unlawful organization/ outfit UG to settle the divorce case in their custody which is very Illegal in nature. Now self and my family members were not in safe and secure at the moments.

Therefore, it is requested to find out those involved miscreants who threaten me and family members and to take necessary action as per law
