Sub:- Report

That my son Laishram Henba Singh aged about 34 years, S/o L. Ranjit Singh of Sekmaing Awang Leikai, Imphal West is running a car repairing workshop in the name and style of "Henba Automobile" at Khabam Lamkhai Matai Garden road.

That on late night of 27/11/2023 at about 10:30 pm my son Laishram Henba Singh was called out while he was sleeping at his workshop by four persons out of which two are Meitei and another two are Muslim (Meitei Pangal) and seriously beaten with iron rod and hammer in front of his workshop. As a result of which my son was seriously injured and fell unconscious. In the morning of 28/11/2023 some of his family members found my son lying unconscious in front of his workshop. Thereafter he was brought and admitted at Advance Hospital for treatment. As doctor advice he left Imphal for Delhi for further treatment on 05/12/2023.

That the four persons stated above have also taken away the CCTV camera along with receiver and monitor.

That on 04/12/2023 my son came to his consciousness and told that he was beaten by above stated four persons. I could not report for the matter as my son came to his consciousness only on 04/12/2023.

It is therefore, prayed that Hon'ble Sir may take up necessary legal action against the above stated four person and investigate the matter and punish according to law as early as possible.
