Subject:- Report

Sir,

I have the honour to state that today i.e. 09/12/2023 at about 12:00 pm received a reliable information about the presence of some arms smuggler in and around Khabam Lamkhai area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS Addl. SP(Ops) IW and under the overall supervision of Shri Ksh, Shivakanta Singh, IPS, SP-IW rushed to the said area after given prior information to Imphal East Police control room and conducted search operation at Khabam Lamkahi Bazar. During that one unknown person with a camouflage bag was found standing at the northern side of the newly constructed gate located at Khabam lamkhai Bazar in a suspicious manner. Due to his suspicious manner he was detained at the spot for verification and checking. During spot body search one camouflage side bag containing one .32 pistol marked with "MADE IN GERMANY" along with one Magazine and one OnePlus 6t mobile handset along with one Airtel SIM Card bearing number 8991160990017205184U (Ph No. 9362841247 as disclosed by him) were recovered from his Possession.

Later on he identification himself as Hijam Shyamsunder Singh (22 yrs) S/o H. Loken Singh of Awang Potsangbam Khunou, Imphal East District. On further verification, he disclosed that the above mentioned .32 pistol was bought from one Da Nao (Ph. No. 8974925667) from Kairengei in the month of October, 2023 by paying a sum of Rs. 55,000/- (Rupees fifty five thousand only). He further disclosed that, he came to Khabam Lamkhai today to sell the above recovered .32 pistol at an amount of Rs. 68,000/- (rupees sixty eight thousand only) to one person who contacted him through his mobile phone. Hence, he was arrested at the spot at 12.40 pm and seized the above recovered articles at the spot at 12.55 pm by observing formalities.

The arrested person and seized articles are handed over to you for taking further necessary legal action against him.
