Most humbly and respectfully I, the undersigned have the honour to state that I represent SuiGeneris Agronomy Pvt.Ltd. popularly known for our brand CC Tea, as a Director of the company having our registered corporate office at The SuiGeneris House, Kwakeithel Lamdong Leikai, P.O- Imphal, P.S- Singjamei, Imphal west - 795001, Manipur and Factory located at Ngarumphung Village, P.O - Litan, P.S - Yaingangpokpi, Kangpokpi District, Manipur - 795010.

Since the unrest in Manipur that happened from 3rd May 2023, we have shut down our factory and couldn't guard it as it falls under one of the sensitive areas of the clash. Since then, the factory remained unguarded and unprotected till now. When we went to take stock of the situation at our factory on 20th November 2023, it has come to light that our factory has been vandalized and most of the machineries are either destroyed or stolen during this clash. Mentioned herewith are the list of Plant & Machineries for your reference and further perusal.
