Sir,

I have the honour to state that, on 14-05-2023 at noon some unknown miscreants suspected to be a members of Arambai Tengol and Meitei Leepun numbering about 50-60 persons carrying deadly weapon and Arms, forcefully attacked and entered our residence school located at Gwaltabi village, under Lungtin Sub- Division Kangpokpi District, Manipur about 30 km East from Saikul-PS and they vandalised my private School, Hand of God Higher Secondary School, a boarding school accomodating about 600 students, looted all the moveable and valuable School properties and destroyed all the remaining school and office propeties.

Fearing lost of live self alongwith my family and the boarding students left our School on 6/05/2023 and fled to the nearby safe villages and as of now we temporarily stayed at Mongkot Chepu relief camp, Ukhrul District, Manipur.

The list of properties destroyed or loss are mention in the Annexure (enclosed). The Approximate value of destroyed or loss properties is calculated at about Rs.78.62,000/- (Seventy Eight lakhs and sixty two thousand).

Due to prevailing law and order situation in the state and lack of safe transportation facilities, I could not report the case in time to the concern Authority.

It is,therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
