Subject: Report.

Sir,

I have the honour to state that , on 06/05/2023 at around 11:00 pm, some unidentified groups suspected to be the members of Meitei Organisation such as Meitei Leepun, Arambai Tengol and other extremist volunteers about 1500-2000 people , carrying sophisticated weapons forcefully entered our village i.e. Lairok Village, PS- Andro under Saikul Sub Division, Island Block, Kangpokpi District, Manipur. In the incident, the miscreants have vandalised my house, looted my household properties like Furniture items , Kitchen items, clothing items, Electronic gadgets, Aactiva Honda 6G registration No. A/F in my name, domestic animals and cattles, rice and grains and other valuable household properties. The miscreants then burnt down my house and remaining household properties into ashes.

The approximate amount of properties lost is estimated at Rs. 30,00,000/- (Rupees Thirty Lakhs).

The incidents could not be reported immediately and timely due to insecurity of our lives and volatile situation of the area.

So, I therefore requested you to kindly take necessary action in this regard.
