Sir,

With due respect , I have the honour to report that today i.e. 03/09/2023, two team of IE/CDO led by JC No. 731 Subedar K. Ibungobi alongwith 1/3 GR , 149 Bn CRPF C- Coy, Keithelmanbi Post and one team of Thoubal Dam PS under the Command of Addl. SP (OPS)-IE and under overall supervision of SP-IE was conducted cordoned and searched operation in an around Keithelmanbi area under Thoubal Dam Police Station from 08:30 am to 10:30 am. In that about 30 (thirty) nos. of houses were searched and occupants of the house verified. No one detained for further verification. Further on foot patrolling near the right side road of Keithelmanbi Dam one plastic polythene yellow in colour was found. After verification the said polythene plastic the undernoted arms and ammunition are found inside the polythene plastic at 10: 15am . The particular of the seized items are as follows :-

1. One suspected to be 9 MM pistol bearing no. B05683 alongwith two Magazine.
2. Six nos. of live round suspected to be 9MM ammunition

And prepared a formal seizure memo in presence of the witnesses.

It is, therefore, the seized items and seizure memo are being handed over to you for taking further necessary legal procedure.
