Sir,

With due respect, I have the honour to report that today i.e. 08/09/2023, two team of IE/CDO led by JC No. 752 Sub. N. Bobo Singh assisted by HC. Th Rajesh Singh alongwith 1/3 GR, 149 Bn CRPF C- Coy, Keithelmanbi Post and one team of Thoubal Dam PS under the Command of Addl. SP (OPS)-IE and under overall supervision of SP-IE conducted cordon and search operation in an around Laikhong & Bewalaland area under Thoubal Dam Police Station from 09:30 am to 01:00 pm. In that about ten no of houses (10) were searched and occupants of the houses were verified. No person was detained for further verification. Further on foot patrolling near the Bewalaland by the outer cordon group, a green coloured fertilizer sandbag was found. After inspection of the sandbag the undernoted arms and ammunition were found inside the sandbag at 12:40 pm.

The particular of the seized items are as follows: -

1. One suspected to be 9 mm Carbine made in Zogam, weapon bearing no. NA without Magazine.
2. Ammunition - Four nos. of 9 mm live rounds.
3. No 36 Hand Grenade bearing No 994J KF82.

And prepared a formal seizure memo in presence of the witnesses.

Therefore, the seized items and seizure memo are being handed over to you for taking further necessary legal procedure.
