With due respect and humble submission I, the undersigned have the honour to inform you the following few lines for your kind consideration and favourable necessary action that on between 10th June, 2023 to 22nd June, 2023 some moveable items of Indus Towers Limited (former name as Infratel Tower) located at L. Molnom Village bearing its site ID: UMP329 & Indus ID: IN2061807, PO- Yairipok, PS- Lamlai & Kangpokpi District, Manipur have been found lost. And it is found suspected to be related with the ongoing ethnic communal riot. And the details of the lost items are given below:

- 1) Diesel Generator (DG) 10 KVA
- 2) EB Transformer
- 3) Battery Bank (24x 600 AH)

And the estimated value of the stolen items were about Rs. 7,00,000/- (Seven lakhs). Due to the present prevailing law and order situation occurred to all the entire districts of Manipur, the report could not be able to lodge in time.

So it is therefore, requested you to kindly trace out whereabouts the abovenoted stolen items at an earliest and take necessary legal action against the unknown persons accordingly.
