I herewith submit this Complaint for losses and destruction incurred on my property at Bongbalkholen Village.

That illegal mining of sand and stone has been carried out at my paddy field bearing dag no. 137, Patta No. 27 (old) and 56 (new) village No. 122 Bongbalkholen, Kangpokpi District Manipur, since the 1st day of September 2023, at around 10:00 A.M. onwards.

The main accused persons are :

1. Shri Sanabam Naocha Singh, about 40 years. S/o Sanabam Rajen Singh of Nungbrang, Makha leikai, P.S Andro.
2. Laimayum Irobot Singh, about 36 years S/o Laimayum Manao Singh of Nungbrang Awang Leikai, P.S Andro.

The total approximate value of the said loot and destruction is Rs. 50,000,00/- (Fifty Lakhs) approximately.

I thus hereby request you to kindly register this complaint as FIR and that the mining works be stopped immediately with necessary legal action initiated against the culprits .
