It is inform with complaint to you that on 29th June, 2023 at around 7:30 A.M. a group of Meitei Organization numbering more than 300 people suspected to be Arambai Tenggol, Kangleipak Lup, Meitei Leepun attacked and looted my rented house (i.e. VAH TRADITIONAL DRESS) at Phuramakhong Bazar, Imphal East District, Manipur, vandalized and looted all my properties (i.e, Kuki Traditional garments, Tangkhul traditional dress and Second hand bale etc.)

✓ Total loss of properties at my rented house would be above Rs.22,00,000/- (Rupees Twenty Two Lakhs) approximate.

I, therefore, request you to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of the justice. I hereby lodge my complaint at your station as I had fled from residence to save myself and my families from the rioters.
