Sir,

I, am to bring to your notice that I am a schedule Tribe belonging to the tribe and a resident of A. Sorongphai Village(Kangpokpi District)795149.

That on the 8th May, 2023 at 3:00 pm, my above said residence (Owned/Rented) was attacked, destroyed, looted and burned by a group of Meeteis/ Meitei radicals.

These criminals broke open the gate(s), destroyed and looted every valuable property from my "owned/ rental" House and premises worth 29,00000/- (Approx.) and they burnt down all the remaining things.

That while carrying out their activities the said Meitei radicals groups were shooting anti tribal Slogan like " HAO HATLO" " KUKI HATLO", KANGLEIPAK YAIPHARE" etc. Hence the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ Zero FIR under relevant section of the Indian Penal Code.
