That on the 8<sup>th</sup> May, 2023 at 3:00 pm, my above said residence (<u>Owned/Rented</u>) was attacked, destroyed, looted and burned by a group of Meeteis/ Meitei radicals.

These criminals broke open the gate(s), destroyed and looted every valuable property from my "owned/ rental" House and premises worth 29,00000/- (Approx.) and they burnt down all the remaining things.

That while carrying out their activities the said Meitei radicals groups were shooting anti tribal Slogan like "HAO HATLO" KUKI HATLO", KANGLEIPAK YAIPHARE" etc. Hence the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/ Zero FIR under relevant section of the Indian Penal Code.
