Sir,

With reference to the above cited subject, I have the honour to report you as follows.

1. That, I Lallom Vaiphei aged about 40 years S/o (L) Tongneilam Vaiphei belonging to the Kuki community, a schedule tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989 and that I am a permanent resident of Gotangkawt, PO/PS Andro, Kangpokpi District, Manipur-795149

2. That at about 4:00 pm on the 6th May 2023, a huge contingent of armed radical Meitei/Meetei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion(IRB) attacked our villages and in the process, they have looted, Vandalized and torched my house.

3. That it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 31 Lakhs (Rupees Thirty One Lakhs) Only.

4. Fortunately, me and my family managed to escaped from these criminals who eventried to kill or burn us alive, and now currently taking refuge at Churachandpur Govt. College Relief Centre.

In the given Circumstances, I humbly pray you to kindly register an FIR/Zero FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
