Subject: Report on looting ,vandalism and burning of house, household iotems/assets.

Sir,

With reference to the above cited subject, I have the honour to report you as follows.

1. That, I Haoneilal Vaiphei aged about 32 years H/o Tinhoikim Vaiphei belonging to the Kuki community, a schedule tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST ( Prevention of Atrocities) Act, 1989 and that I am a permanent resident of Lairok Vaiphei, PO/PS Andro , KPI,District, Manipur-795149
2. That at about 11 noon on the 6<sup>th</sup> May 2023, a huge contingent of armed radical Meitei/Meetei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian Reserve Battalion(IRB) attacked our villages and in the process. they have looted , Vandalized and torched my house.
3. That it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 1500000 (Rupces Fifteen Lakhs) Only.
4. Fortunately, me and my family managed to escaped from these criminals who eventried to kill or burn us alive. and now currently taking refuge at Kholmun Relief Centre.

In the given Circumstances, I humbly pray you to kindly register an FIR/Zero FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness. I shall always remain thankful to you and obliged.
