I, the undersigned would like to state few line before your kind consideration and sympathetic action that on 6<sup>th</sup> May at around 10:00 am, Meitei organisation numbering around 1000 (one Thousand) suspected to be Arambai tenggol , Kangleipak kanba Lup, Meitei Lepun attacked my residence , destroyed and looted my preoperty of W. Lunjemson Vaiphei of Kamu Tampak Vilage Po- Yairipok PS- Andro Kangpokpi District, Manipur.

**The cost of property damaged and looted by the Meitei Organisation are given below:-**

- 1) House structure completely burnt down- 25 lakhs
- 2) Kitchen Items – 8 lakhs
- 3) Clothing materials – 8 lakhs
- 4) Granary- 17 Lakhs
- 5) Poultry farms / rearing – 21 lakhs

I therefore request you to look into the matter and file and FIR at your station for further necessary action.
