## Dear Sir/ Madam,

With reference to the above cited subject, i have the honour to report to you as follows:-

- That I am a schedule tribes belonging to the vaiphei Tribe, which is a recognised tribe under the constitution of the india and . I am a permanent resident of kamu tangnom Village, PO- Yairipok, PS- Andro and District:- Kangpokpi Manipur.
- That on the 6th of May, 2023 at about 04:30 pm a huge contingent of armed radical Meitei/ Meetei suspected to be member of the Arambai tenggol and Meitei leepun headed by the Manipur State force like the Manipur Police Commando and Indian reserved Battalion (IRB) 2) attacked our villages and in the process they have looted vandalized and torched my house.
- That it may be reported here that the miscreants were shouting slogans like 'kangleipak Yaiphare' Kuki hatlo' hao hatlo etc while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur state Government as 3) the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that no harm could be done to them.
- That, at the time of the attacks we somehow managed to escaped to save our lives under the compelling circumstances and thus could not take our belonging including important documents like pension cards, Aadhar Cards, ATM cards, Pan Cards, Educational certificate, Apart from other tangible materials. A least of our properties looted/ destroyed/ burnt is attached here under with each estimated cost. The total lost suffered is Rs. 8680000( Eighty six lakhs and eighty thousands) only
- That I am filing these application lately, because there is great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I am settled at Relief centre at Churachandpur College, which is set up/ organized by the Young 5) Vaiphei association (YVA) and thus I am filing the report lately today.

In the given circumstances, I humbly prayed you to kindly registered a Zero FIR, Investigate the matter and punished the perpetrators as per prevailing provision of the law of our country. And. for which act of kindness, I shall always thankful to you and obliged. Enclosure:
