I have the honour to state that on 04/05/2023 at around 3:30 pm my son namely C/No. 8018591, Thanglenmang Khongsai (33) yrs who went out for some domestic work at Andro and Changamdabi Village , Thoubal District Manipur, did not return home till date, his whereabouts is also not known. It is learnt that he was being murdered by some unknown miscreants suspected to be a member of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and world Meitei Council (WMC), Schedule Tribe Demand Committee (SDTC) on the same day. However the whereabouts of the dead body is not known till date.

It is therefore requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
