Sir,

With due respect, I have the honour to state that on the 6<sup>th</sup> May, 2023 at around 11:00 am, miscreants numbering more than 500 people from Meitei community suspected to be members of Arambai Tengol and other Extremist volunteers by holding deadly weapons like automatic rifles attacked our village i.e. Lairok vaiphei Village, PO- Yairipok, PS- Andro, Kangpokpi District. The miscreants have looted my household properties, two wheeler Vehicle MN 01Z-2404, live stocks and other valuable property. The miscreants after looting household properties have burnt down my house and left behind properties and granary store into ashes.

The approximate amount of my burnt down properties are estimated at Rs. 50,00,000/- (Rs. Fifty Lakhs Only).

The incident could not be reported immediately to my concern PS as well as in time due to the prevailing law and order situation in the state.

I therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
