With due respect and humble submission, I beg to state on 06/05/2023 at around 11:30 am Some unknown miscreants armed youths suspected to be People Liberation Army (PLA), United National Liberation Front (UNLF), Kanglei Yaowon Kanna Lup (KYKL) and PREPAK cadres assisted by Meitei Youth Organisation of Arambai Tenggol, Meitei Leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 members carrying sophiscated like AK Rifles. SLR forcefully entered my village Kamu Tangnom PO- Yairipok, PS Andro Isand Sub Division Kangpokpi District Manipur after looting all the valuable household items and properties. My housed was burnt down to ashes leaving homeless. Apart from that some important parts of my house i,e Kitchen shed,Cattle Shed with 10 (ten) Cattles, Pig shed with 5 pigs, Poultry firm with 50 Chickens, Sofa set Table wikth Chairs, MI.TV 53 cm were also totally burnt down including one TATA XENON (Black) Registration No. MN01G3500 four wheelers vehicles and 1 no. of Two wheelers Activa Vespa were lost. The approximate value of lost properties is estimated at about RS. 1.2 Crores. (One crore twenty Lakhs).

I is therefore requested to kindly register ed a regular case and take necessary legal action according to law.
