Subject: Report

Sir,

I have the honour to state that on 06-05-2023 at around 11:30 am some unknown miscreants belonging to Meitei Youths organisation of Arambai Tenggol, World Meitei Council(WMC), Meitei Leepun and Kangleipak Kanba Lup(KKL), numbering about 700-1000 members carrying sophisticated weapons like AK Rifles, SLR and .303 Rifles forcefully entered my village, Kamu Tangnom PO- Yairipok, PS- A ndro, Island Sub Division Kangpokpi District, Manipur, having 65 houses, after looting all the valuable household items the house and properties has been burnt down to ashes leaving us homeless. Moreover one villager namely Mr. Laljathang Vaiphei(57)yrs S/o (L) Lalneilun Vaiphei of is also killed in the incident. Apart from the house some important building like church, School, Veterinary Hospital, Angalwadi Centre and Church Kitchen, cattle shed were also totally burnt down. Some cattles numbering about 50-70 cows, Oxen, pigs, dogs, chicken are lost and 10 Nos. Of four wheeler vehicles and 20 Nos. of two wheeler were also lost. The Approximate value of the lost properties is estimated at about Rs. 100-120 crores.

It is, therefore, requested to kindly registered a regular case and take necessary legal action according to law.
