Respected Sir,

With due respect and humble submission, I beg to state on 06/05/2023 at around 11:30 am, Some unknown miscreants armed youths suspected to be People Liberation Army (PLA), United National Liberation Front (UNLF), Kanglei Yaowon Kanna Lup (KYKL) and PREPAK cadres assisted by Meitei Youth Organisation of Arambai Tenggol, Meitei Leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 members carrying sophisticated like AK Rifles, SLR forcefully entered my village Kamu Tangnom PO- Yairipok, PS- Andro, Island Sub Division Kangpokpi District Manipur, after looting all the valuable household items and properties. My house was burnt down to ashes leaving homeless. Apart from that some important parts of my house i.e Kitchen shed, Cattle Shed with 3 (Three) Cattles, Pig shed with 7 pigs, Poultry farm with 45 Chickens, Sofa set, Table with Chairs. Almira, Refree generator, MI TV 53 cm were also totally burnt down including One No. of two wheelers Activa were lost.

The approximate value of lost properties is estimated is about Rs.50 (Fifty) Lakhs.

I is, therefore, requested to kindly registered a regular case and take necessary legal action according to law.
