I have the honour to state that today i.e. 29/08/2023 at 16:45 pm I have reported to you that on a specific input write presence of wireless system in General area Kamu Ridge (Notified Area) of Kangpokpi District Manipur. After confirming the inputs from the wireless system a coloumn of 33 Assam Rifles was launched at by under command Major YS Singh at 29/08/2023 10:45 hrs. On arrival at said location extensive search was carried out and following wireless system recovered from Upper side of "Site for Research centre for Medicine Plants. After searching for almost 50 minutes the teams found was like stores. The items are recovered on ground checked thoroughly. The seized items are as follows 1) 9 mm Pistol -1 (one) nos.
