Sir,

I am to bring to your kind notice that I am a Schedule Tribe (Kuki/ Zoo) and a resident of Gotangkot Village, Kangpokpi District that on the 6<sup>th</sup> May, 2023 at 01:00 pm, my above said residence (Owned/Rented) was attacked , destroyed , looted and burnt by a group of Meetei/ Meitei radicals.

These criminals broke open the gate(s), destroyed and looted every valuable property from my "owned/ rental" House and premises worth Rs. 3245000/- (Approx.) and they burnt down all the remaining things.

That, while carrying out their above said criminal activities , the said Meitei radical groups were shouting anti Tribals slogans like – " HAO HATLO" , "KUKI HATLO", KANGLEIPAK YAI PHARE etc . Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong action against the perpetrators by registering an FIR/ Zero FIR under relevant sections of the statutes of our country.
