Respected Sir,

I the undersigned would like to state few lines before your kind consideration and sympathetic action that on the 6th May 2023 at around 10:00 am, Meitei organisation numbering more than 1000 (One Thousand) suspected to be the Arambai Tenggol, Kangleipak Kanba Lup, Meitei Lepun attack my village, destroyed and looted all the properties of houses and all numerous and valuable costly items and burnt down all the houses after looting of the properties of the whole houses of the village of Kamu Tampak Village PO- yairipok, PS- Andro, Kangpokpi District, Manipur. The cost of property damaged by the Meitei organisation are given below-

1. No. Of house burnt down 37
2. No. Of 4 wheeler looted 15
3. No. Of two wheelers burnt & destroyed 20
4. Church burnt down
5. Other valuable items destroyed /looted
6. School burnt down
7. Community hall burnt down
8. No. Of shops burnt down 3

And estimated loss of property worth around 30-40 crore

I therefore request you to kindly look into the matter and file at your police station for further necessary action
