Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

1. That I.T.S Anek Vaiphei aged about 72 years S/o (L) Lamtinkhup Vaiphei, belonging to the vaiphei tribe/Community, a schedule tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act,1989.
2. That I am a permanent resident of Heirokland PO/PS Andro Kangpokpi District, Manipur-795149 and I am the School board Chairman of Heirokland Primary School.
3. That at about 1:00 pm on the 6<sup>th</sup> of may 2023, a huge contingent of armed radical Meitei/Meetei suspected to be members of the Arambai Tengol and Meetei Leepun along with various state forces like Manipur Police Commando and Indian reserved Battalion (IRB) attacked our villages and in the process, they have looted , vandalized and torched/ gutted Heirokland Primary School.

In the given circumstances, I humbly pray you to kindly register an FIR/Zero FIR , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country.

And for which act of kindness , I shall always remain thankful to you and obliged.
