Subject: First information report on the crimes of looting, vandalism, arson, attack and discrimination of schedule tribes.

Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a schedule tribe belonging to the vaiphei tribe, a recognized Schedule tribe under the constitution of India. And I am a permanent resident of Zerukanan Village, PO-Yairipok, PS-Andro, District-kangpokpi, Manipur.

That on the 6th of May,2023 at about 1:30 pm, we escaped for our lives as we noticed a huge contingent of armed radical Meitei/Meetei, suspected to be members of Arambai Tanggol and Meitei Leepun along with the local Meeteis in and around the areas, attacked our neighbouring Pheitaiching Village and in the process they have looted, Vandalized and torch the houses, Killing one of the Villager's namely Thiandan Vaiphei(50)yrs. And After the attack on the neighbouring Village, it was our Village that they looted, Vandalized and torched it down to ashes and by the grace God, we have already escaped from our Village.

That, It may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 59 Lakh (Fifty Nine Lakhs) only.

That I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and I am settled at a relief Center at Mata, CCPur Dist. Which is set up/organized by the Young Vaiphei Assaociation (YVA). And thus I am filing the report lately today.

In the given circumstances, I humbly pray you to kindly register a Zero FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And for which act of kindness, I shall always remain thankful to you and obliged.
