Sir,

I have the honour to report you that on date 06/05/2023, a group of people belonging to Kuki tribe including kuki militants group have enter at my house located at Tuinomphai Village. PS. Andro, District-Kangpokpi. Manipur and have burnt, attacked and destroyed my house. asset and properties which left me and my family homeless. The mob was armed with spades, axes, Sticks and other deadly weapons. They also forcefully took away some domestic animals including cows, pigs, dogs etc. The approximate value of the burnt and lost items is about Rs.12 lakhs. I along with my family members my wife and 2 son, 1 daughter-in-law and 1 grand daughter fled from my house for survival and presently took sheltered at Andro Loupaochum Schedule Cast Girls Hostel Relief Camp.

I, request your good self to intervene in this matter urgently and protect our property and our life and limp from any further lost or damage. You are also requested to register an FIR and take up necessary action against the culprits according to law. Thanking you for your Anticipation.
