Subject: Report

Sir,

I have the honour to report that today ie 17/10/2023 based on reliable information, a cordon and search operation led by Sub L. Bebekananda Singh OC Special CDO Khabeisoi under the Supervision of Kh. Herojit Singh, MPS Addl. SP (Ops) overall guidance of Th. Krishnatombi Singh (MPS) SP/Railways and in-charge Special CDO Unit, Khabeisoi was conducted in Ngariyan Hills under Andro PS, Imphal East district by 12 (twelve) teams of Special CDO Unit, Khabeisoi from 6.10 pm to 7.00 pm.

In the search operation, the said teams of Special CDO Unit, Khabeisoi searched abandoned huts and other suspected human dwelling places along the Andro-Ngariyan road in Ngariyan Hill area. During the search process, the team led by L. Bebekananda OC/Special CDO including myself SI Y. Kayel Kumar Singh and HC Hijam Omega Meitei detected two nos. of jute gunny bags and a suspected long range weapon covered with a meitei khudei mixed light purple and green in colour in a bush near a pillar marked as NRF which is located approximately 130 meters south west to abandoned and decayed Don Bosco school building. When opened the said two gunny bags and the Meitei Khudei, the following articles were found inside. Details of the articles are:

1. 1 (one) no. INSAS rifle bearing body no. 18407556 having one magazine, with 12 live rounds.
2. 4 ( four ) nos. of another live round bullets
3. 10 (ten) nos. of Bomb mark as "WP Green no. 80 MK1"
4. 15 (fifteen) nos. of Bomb detonator mark as "OT "
5. 36 (thirty-six) nos. of Bomb detonator mark as "DETONATORS No. 36M GRENADES"
6. 14 (fourteen) nos. of detonators mark as " DETONATORS no 75 MK.2"
7. 2 (two) nos. of HE Bomb High explosive mark as "3 MOR.H.E."
8. 4 (Four) nos. of ammunition green container (box) mark as i) "36 M GREEN RIFLE", ii) "NO. 80 WP", iii) "3 MOR.H.E-LRS. FUZ 162", and iv) "6REN"
9. 2 (two) nos. of jute gunny bags and
10. 1 (One) no. of meitei khudei mixed light purple and green in colour.

Hence, the said articles are seized from the said spot at 6.50 pm by observing necessary legal formalities and the said seized items have been handed over to Andro PS for further legal formalities.
