Sir.

I am to bring to your kind notice that I am a residence of Vaiphei Patkai Village, PO- Yairipok, PS-Andro, Island Sub Division, Kangpokpi District. That on 4th may, 2023 at around 10:00 am my permanent residence was attacked, destroyed, looted and burned by a group of Meetei/ Meiteis radicals.

These criminals broke my gate, destroyed and looted every valuable property from my residence and premises worth Rs. 29 Lakhs(Approx.) and they burnt down all the remainings. The list of stolen and torched down properties are shown in Annexure-I as movable and immovable properties. While carrying out their said criminal activities the said Meitei radicals were shouting anti tribal slogans.

I therefore request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant section of law.
