Sub:- Report.

Sir,

I have the honour to report that today i.e. 27th October, 2023 at about 11:30 a.m. received a reliable information about the presence of some anti social elements in and around Yairipok Yambem and Changamdabi area of Imphal East District stating that they (anti social elements) were extorting money from the heavy vehicles plying at Yairipok-Keithelmanbi road. Based on the said information, a combined team of CDO/IE led by Inpst. Kh. Henery Singh OC-CDO/IE assisted by Inspt. Kh. Pathou Meitei and a team of Andro Police Station led by ASI. H. Birchandra Singh under the command of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)Imphal-East and under the overall supervision of Shri. Dr. S. Ibomcha Singh, MPS Superintendent of Police Imphal East District was organized and rushed to the said area and conducted a cordoned and searched operation at the said area at 12:10 p.m.

During that, our combined team detained one car (Hyundai i20) and five unknown suspected persons at Yairipok Changamdabi near Primary School. On checking the car there found; (i) 20 (twenty) nos. of 7.62 SLR Live Ammunition, (ii) 4(four) nos. of .38 live Ammunitions, (iii) 12 nos. of INSAS Ammunitions, (iv) 6(six) nos. of AK- Ammunitions, (v) 4 (four) pair of Jungle Boot shoes, (vi) 3 (three) pairs of fighting dress with one scarf, (vii) 1 (one) BP Jacket, (viii) 3 nos. of 7.62 Ammunition charger clip, (ix) one wallet, (x) two nos. of mobile phones. On checking one of the detainee (Sadokpam Nongpoknganba Singh); there found one .32 pistol loaded with six live rounds in the magazine along with holster, one mobile phone and one wallet.

On verification the detainees identified themselves as *Singam Kabikanta Singh (31) S/o S. Biren Singh of Thoubal Wangkhem Mamang Leikai, Thoubal Dist, (ii) Ngangom Tangba Meitei (30) S/o (Late) Ng. Ingocha Meitei of Sekta Mayai Leikai, Imphal East (iii) Sadokpam Nongpoknganba Singh (22) S/o S. Kouremba Singh of Yairipok Phangjakhong, Thoubal, (iv) Konsam Anao Singh (26) S/o K. Thoiba Singh of Mayang Imphal Thana Mamang Leikai and (v) Md. Ilyas Khan (30) S/o (Late) Md. Waris Khan of Yairipok Changamdabi Makha Leikai, Imphal East.* On further verification, the detainees stated that they were active members of the outfit KCP (Military Task Force) presently working under the command of one s/s - Army Chief Mr. Lanthoi @ Max of KCP (MTF). They further stated that, on the advice of the said, Lanthoi @ Max of KCP(MTF) today they were extorting money from the heavy vehicles plying at Yairipok-Keithelmanbi road. So, the detainees were arrested from the spot i.e. Yairipok Changamdabi near Primary School at 1:15 p.m. by observing necessary formalities.

From the possession of the arrestee Singam Kabikanta Singh, our combined team seized; (i) 20 (twenty) nos. of 7.62 SLR Live Ammunition, (ii) 4(four) nos. of .38 live Ammunitions, (iii) 12 nos. of INSAS Ammunitions, (iv) 6(six) nos. of AK- Ammunitions, (vi) 4 (four) pair of Jungle Boot shoes, (vi) 3 (three) pairs of fighting dress with one scarf, (vii) 1 (one) of BP Jacket, (viii) 3 nos. of 7.62 Ammunition charger clip, (ix) one wallet containing one AAHAR, Voter and PAN cards and (x) two nos. of mobile phones - (a) Oppo F1S bearing IMEI no. 863184037441571 & 86318403744151763 without SIM cards and (b) Redmi Note 9 Pro bearing IMEI no. 868448043339136 & 868448043339144 along with two SIM cards bearing no. Airtel - 8991160990021503945U & Jio - 89918650400115643621 and (xi) One car (Hyundai i20) Fine Grey in colour, bearing Engine no. G4LA9M158196 and Chassis no. MALBB51BR9M056822 from the spot i.e. Yairipok Changamdabi near Primary School by observing due formalities at 1:40 p.m.

One .32 pistol, marked as 'IN GSF 190213432' loaded with six live rounds in the magazine along with holster, one mobile phone (Realmi RMX 3231) bearing IMEI no. 867271050668457/01 & 867271050668440/01 along with one Airtel SIM card bearing no. 8991160990020110442U and one wallet containing a sum of Rs. 70/- (seventy rupees) were seized from the possession of the arrestee Sadokpam Nongpoknganba Singh at about 1:55 p.m. by observing due formalities from the spot i.e. Yairipok Changamdabi near Primary School.

From the possession of the arrestee, Ngangom Tangba, one mobile phone (Redmi 9) bearing IMEI no. 861269053952593/01 & 861269053952601/01 along with one Airtel SIM card bearing no. 8991160990017459383U was recovered and seized by observing due formalities at 2:05 p.m. from the spot i.e. Yairipok Changamdabi near Primary School.

From the possession of the arrestee, Konsam Anao Singh, a sum of Rs. 2020/- (two thousand and twenty rupees) was recovered and seized by observing due formalities at 2:15 p.m. from the spot i.e. Yairipok Changamdabi near Primary School. One mobile phone (POCO C31) bearing IMEI no. 867811065740898/78 & 867811065740906/78 along with Jio SIM card bearing no. 89918650400105247599 was recovered and seized from the possession of the arrestee Md. Iliyas at 2:25 p.m. by observing due formalities from the spot i.e. Yairipok Changamdabi near Primary School.

Therefore, the arrested persons along with seized items are being handed over to you for taking up necessary legal action against them.
