Subject: Lodging FIR over lost of house and properties.

Sir,

I have the honour to state that, on the 22nd June, 2023 at around 4.00 PM some unknown miscreants belonging to Meitei individuals with sophisticated armed weapons had broke my house and destroyed my household items which was located at Songjang village under Sagolmang Police Station, Kangpokpi district, Manipur. In the process these individuals had vandalized my properties and looted all my valuable items. The approximate value of the destroyed and lost properties are estimated to be about Rs.15,54,500 (Fifteen lakhs, fifty-four thousand and five hundred)

The details and the approximate value of each I have lost are as under:
