

Sir,

I have the honour to report that my nephew, namely Mr (L) Mangminjoy Haokip (20) yrs S/o Paokhongam Haokip, a permanent resident of C.Aisan Village, under Saikul Police station received bullet injuries on his person suspected to be fired by Imphal East District Police at near Leitarpokpi Police Out Post on 04/05/2023 at @ 3:00 am while he was present in the crowd during communal conflict. After that he was brought to CHC- Saikul by local public in the same morning and declared death by the MO In-charge CHC- Saikul and Death Certificate was also issued on the same.

The dead body of (L) Mangminjoy Haokip was taken home by family members and formal burial service was performed on the same day at C.Aisan Village, as per Kuki customary ritual. I could not report in time to the Police Station due to inconvenience caused by present ethnic conflict and prevailing law and order situation in the state of Manipur.

It is therefore, request you to kindly take up necessary legal action.
