Sir,

I the under signed have the honour to state that I am the residence of Pukhao Ahallup . My house is situated near the bank of Iril River. On 09/05/2023 at about 12:30 am, while I along with my family members sleeping inside our house. I saw a big flame through window. In that, I along with my family member came out from our house and saw our Granary cum store room was burning suddenly I was Shouting for help. In that movement some unknown persons was ran away by taking advantage of the darkness and escape away . Our neighbour rushed there and put off the flame. However, all the properties kept inside the granary and store room were reduced to ashes.

The following properties of belonging to me were damaged in the incident.

1. One Granary cum store room (G+1) - Rs. 500000/- approximately
2. 40 bags of paddy grain - Rs.40, 000/- (Forty thousand) only.
3. Two feed making cutting machine set - Rs. 47,000/- (forty seven thousand) only.
4. Seventy Nos. of hen- Rs 35,000/- (Thirty five thousand only)
5. One FZ motorcycle B/Regd. No. MN01L 2499 (Black and green in colour) - Rs. 50,0000/- (Fifty thousand) only.
6. One Honda Activa B/Regd. No. A/F - Rs. 55000/- (Fifty-five thousand) only.
7. One water Pump along with 8 coil of plastic pipe - Rs. 32000/- (Thirty two thousand) only.
8. Electric water pump (Tolu) 2HP - Rs.15, 000/- (Fifteen thousand) only.
9. One welding machine - Rs. 25000/- (Twenty five thousand) only.
10. Net (Hapa) 7 coil - Rs. 8, 400/- (Eight thousand four hundred) only.
11. Two fish net (Nupa een) - Rs. 18,000/- (Eighteen thousand) only.

The above damaged properties worth about Rs. 8,25,400/- (Eight Lakh twenty five thousand and four hundred) only.


I therefore request to kindly taken up legal action against the unknown culprits.
