
With due regard I have the honour to state that today i.e 09/10/2023 in the morning from 3:30am to 5:45am, an operation was launched at Sinam village, Imphal East and its adjoining villages, by a combined team of District Police Imphal East including women personnel led by SP Imphal East, Indian Army Columns under Imphal East region (Red Shield Division), BSF, 4th Bn. CRPF G Company, COs of MR/IRB. In ops, searched around 100 houses in the villages and combed the IVR and by lanes. The operation was overall supervised by IGP (Zone-I) and assisted by DIGP (Range-I).

The following items were found concealed at Sinam Community hall by some unknown miscreants with an intention for committing pre-judicial activities and the same were seized on the same day i.e 09/10/2023 at 4:30 am by observing proper formalities in presence of the witnesses.

The details of the seized items are as follows:-

1. One (1) folding AK 47 Rifle bearing Regd. No. AB447170 along with one Magazine.
2. One (1) empty Magazine of '303 LMG.
3. Twenty (20) Nos. of 5.56 mm ammunition live rounds.
4. Five (5) Nos. BP covers along with three (3) local made BP/ iron plate.
5. One (1) Khaki colour jacket.
6. Three (3) Khaki colour Shirt.
7. One (1) Khaki pant.
8. One (1) Garam Shirt.

The details of the seized items are as follows:-


1. One (1) Carbine bearing Regd. No. C9957, Butt No. 114 along with one Magazine.
