Sir,


With due respect, I have the honour to report that today i.e. 17/10/2023, at about 2:30 a.m. by a combined team of CDO/IE, Sagolmang PS, RL/IE, Special CDO including Woman PS and a column of 2/8 GR led by Inpst. Kh. Henery Singh OC-CDO/IE assisted by ASI. S. Suraj Singh of CDO/IE Unit and ASI. N. Ibotombi Singh of CDO/IE and under the guidance of Shri. Kh. Herojit Singh, MPS, Addl. SP(Ops)IE and under the overall supervision of Shri. Dr. S. Ibomcha Singh, MPS, SP/IE conducted a searched a cordon and search operation in the general area of Nungsum Village and its surrounding Yaingangpokpi hill range located between Nungshum Village and H. Khopibung Kuki Village, Imphal East.

In that, around 80 houses and the resident have verified. During the search operation the under noted arms, ammunitions, explosives etc. were found lying abandoned/concealed at the foothill located between Nungshum Village and Khompibung Village, Imphal East District by some unknown miscreant with an intention for committing pre-judicial activities .
