Sir.

With due respect, I the undersigned have the honour to report that today i.e. 19/10/2023, conducted Cordon and Search Operation (CASO) from 12:00 am to 03:00 pm by a combined team comprising of 8 (eight) CDO teams of Imphal East led by Inspector Kh. Henry Singh, OC-CDO/IE, under the supervision of Shri Kh. Herojit, MPS, Addl. SP Operation Imphal East along with Officer in Charge of SMG-PS and 2nd team led by ASI. N. Birjit Singh of SMG-PS including women police and 2/8 GR at three areas namely Shantipur Village, Khamanlok Village and Wakan Top under the jurisdiction of Sagolmang Police Station, Imphal East District.

In the search operation, the combined team were divided and conducted simultaneous, multiple combing operations and while foot patrolling at the above mentioned villages by the combined team the under noted arms, ammunition, explosives etc were found concealed at the foothill of Pukhao Shantipur, Khamenlok ridge-line and the ridge-line of Wakan Top by some unknown miscreants with an intention for committing pre-judicial activities.
